



Safety sensitive is not an industry term, it is a defined term. Only a few jurisdictions have defined the term safetysensitive, so it is best practice to review any regulations in the states in which you operate. However, safety sensitive exams may include:

- Random Drug Testing
- Post-accident Drug Testing
- Reasonable Suspicion Drug Testing


